It is the consent of the Road Commission Board to not use Road Commission funds for bike paths but encourage grant applications to fund.

Sam stated he had a meeting with Saginaw Asphalt and Highway Maintenance to discuss construction projects.

The crews are changing cross-tubes that have failed at various locations around the county.

Ben stated the mechanics have removed the salt spreaders from the trucks and are installing the shoulder spreaders to begin maintenance work.

He and Sara put together totals for the winter blades used this year and have seen a significant savings of approximately \$11,000. The trucks are able to spend more time on the road and the mechanics and service man can do other repairs because they are not changing as many blades. Overall feedback from the truck drivers was good.
