Discussion on Road Millage renewal. Terry has talked with Jon Lynch and Brian McManus and it was agreed to put renewal on the November ballot.

## **New Business:**

A contract was received from the Michigan Department of Transportation regarding widening for center lane construction work along Gordonville Road from approximately 0.34 miles west of Badour Road easterly to approximately 0.11 miles east of Badour Road; including earth excavation, sand subbase, aggregate base, culvert, storm sewer, hot mix asphalt surfacing, and concrete curb and gutter work; and all together with necessary related work.

Terry stated there has been an increase in the federal funding for this project and it is scheduled for bid letting May 6<sup>th</sup>.

WHEREAS, at the request of requesting party, the project is programmed with the Federal Highway Administration, for implementation with the use of Federal Funds under the Surface Transportation Program.

WHEREAS, the parties hereto have reached an understanding with each other regarding the performance of the work and desires to set forth this understanding in the form of a written contract.

THEREFORE BE IT RESOLVED, that the Board of County Road Commissioners, County of Midland, authorizes Terence Palmer, Managing Director and Janice Leatherman Sagle, Board Chairman to sign Contract 16-5180.

Tom Smith from the auditing firm of Smith and Klaczkiewicz, PC gave a presentation on the new GASB 68 accounting standards regarding the reporting of unfunded pension liability. He will be incorporating the new standards into this year's financial audit.

#### **Staff Reports:**

Art attended a field manager meeting last week.

He stated the Rural paving projects will start June 6<sup>th</sup>.

He attended a utility meeting on Gordonville and Badour and they are relocating cable.

Russ stated he is working on critical bridge applications and safety grants to be submitted this month.

Sam will be sending the Foreman to a Temporary Traffic Control workshop.

He has met with Highway Maintenance regarding our chip and seal program. We have 8.5 miles of local road to sealcoat.

He will be ordering County Salt to be delivered in the fall.

Terry attended the MPO meeting, there is a 2% increase in funding and all our projects have been approved.

He discussed the proposed construction projects for paving, bridge work and primary sealcoats for this year.

Mike stated the potholes need patched on Bombay Road between Eastman and Stark Road.

Janice discussed plugged driveway culverts and the responsibility of the property owner to clean them out.

She would like to notify townships when closing bad roads and pulling shoulders so they can answer questions from residents when asked.
