Russ attended the Midland Area Transportation Study (MATS) Open House regarding future projects. The open house was well attended. Russ reported approximately \$33,000 has been submitted to MATS for reimbursement this year for services.

Art stated the Coleman Road bridge was scheduled to be complete Oct. 18. Contractor was given a one week extension until Oct. 25. The contractor is hoping to have bridge completed the first week of November and will be charged for liquidated damages each day.

Ben reported the mechanics are working on getting the trucks ready for winter. He would like to have them ready by November 15.

He is going over specifications for new tandems to bid in 2016.

He is going to start changing parking lot lights into LED's.

Commissioner Atton suggested looking into new mower tractor to have delivery in the early spring.

Sam commented the drainage projects are progressing nicely.

The line stripping is nearing completion.

He is preparing for a safety day "truck rodeo" on October 26. The crew will participate in various activities involving the trucks, loaders and excavators. Lunch will be provided by Road Commission.

Terry commented the culvert replacement under the Shaffer Road bridge is complete. He would like to do a couple GRS IBS bridges next year and will be contacting Spicer to start surveying.
