Staff Reports:

Russ stated we are replacing 8 computers and they should be set up in the next couple weeks. Ashleigh is continuing to work with us a few hours a week while also working at the MPO and the County GIS.

Art stated he is working with the auditors closing out last year's projects and getting the bid information ready for 2017 projects.

Ben is finishing up on the two brine tank conversions. The shop guys are very busy keeping up with repairs.

Sam stated he is working with the townships on projects for this year.

He stated there is a new company offering educational videos on the benefits of paser ratings to educate employees, township officials, and others on why and how roads are rated. They also have training videos along with safety videos.

Sam and Art attended a meeting on brush spraying and the different bid specifications for the spray program. They are looking into adding a warranty clause in the bid process and use the GIS for tracking.
