Miscellaneous:

A letter of understanding has been received from MDOT for winter night patrol 2021/2022 contract year and will run from November 14, 2021 – March 31, 2022.

Staff Reports:

Ben stated the Navistar Maxforce Engine lawsuit settlement resulted in payment of just under \$10,000 for the four trucks currently in our fleet with the effected engine.

The winter prep has been completed on all the snow plow trucks.

The new brush cutter framework has arrived at Hutson and they are going to start the build.

Jon stated he attended the Regional RTF meeting at Isabella County Road Commission and projects have been set for 2022 and 2023. Projects have been reviewed through 2026 and the illustrative list has been updated. MDOT has determined counties will be able to use the additional RTF COVID funds for lost revenue during the pandemic.

He attended a meeting with the Midland Area Community Foundation regarding grant application for the Bailey Bridge.

He has been driving all the primary roads with Art, Russ and Jeff to review projects for next year. Jon gave an update on the flood repair projects;

He stated he has been having issues with permits and plan approval on the NRCS flood repair projects from 2020. Meridian Road, Airway Drive, Anna Lane, Lake Sanford Road, and West River Road have all been extended for construction in the spring. The flex-a-mat projects on Blackhurst Road, Lewis Road and Alamando Road have been completed and went very well.

The contractor is continuing to work on 8 Mile Road repair and hopes to pave tomorrow and open to traffic by the end of next week.

He has submitted a contract extension for the FEMA flood projects on Grey Road, Stewart Road and Olson Road for completion next year.

All the third-party agreements for the FHWA flood projects have been submitted to MDOT but have not been approved yet.

Jon attended MI CIMS training for Midland County Emergency Management services last week. He has been asked to be a part of the County-wide broadband committee that will start meeting in December.

Art stated the crews have done a great job this construction season. They had a very busy summer and got a ton of work done. It enabled the mechanics to get the plow trucks ready for winter ahead of schedule.

He has been working on five-year plans for the townships and will soon be meeting with them to plan local road construction projects for 2022.

He has been working on the EGLE reporting compliance requirements for permitting for our brush spray program.

We have been getting reclaimed sand from the windmill project at a very good price. We have quite a pile at the Ingersoll and Sanford garages.

Chairman Atton inquired about the merger with TCF and Huntington Bank. Brenda stated it has been a learning process and there are still issues with ACH payroll and checks clearing.
