Staff Reports:

Art reported that township estimates for 2024 construction projects are out. Two townships have already returned their signed estimates. The weather has been very good, so crews have been

out at the clay pit doing clean up, grading gravel roads one last time before snow hits and finishing tree cleanup.

Jon has been busy with implementation of the various technologies we will be using in the new year. He has the Everbridge software set up for employee call-in and notifications with testing underway. He attended several incident command training courses online that he was required to complete because he is the backup Road Commission representative for the E.O.C. He also attended a meeting regarding internet connectivity activities in Midland County. He mentioned that the East Central Council meeting is scheduled for January 18, 2024, but so far we haven't had any communication about it yet.

Donna has been busy preparing for the end of the year and the "go live" date for the new accounting software. She also gave an update for Steve, who was absent from the meeting. Steve reported that the Samsara units have been in installed in truck 642 fully and partially installed in 638. Both cameras are active. He also has Blasey Electric coming to install exterior lighting upgrades at the Sanford building. Steve also stated that Jeff's new truck is in the shop being outfitted and would be in service soon. He also reports that all equipment is currently up and running with no equipment down.

Russ has been busy with several computer issues that took up a lot of his time between the holidays. He gave an update on the Poseyville Rd. FHWA flood repair project. They are working on a time extension and waiting for approval so they can get submit the project for bids. There is a plan for a second Letts Road Connector Open House, tentatively set for Monday, February 12, 2024, from 5-7 pm at the Larkin Township Hall, which he will begin advertising as soon as he confirms availability of the Township Hall.

Jeff has been getting the first batch of material bids out for advertisement, which are due the 16th of January and will be presented at the board meeting on the 17th. He has also been working on surveys for a few large culvert replacements scheduled for 2024.

Ashley has been working on a 2023 recap video and Impress Award submissions, which are due January 12th.

Travis is finishing up the TAMC Asset Management Plan and then will be working on design for 2024 culvert replacement projects next week.

Commissioner Cozat complemented everyone on a good year and is looking forward to a great 2024.
